This clarification text has been prepared to transparently inform you about the purposes and legal reasons for the collection and processing of your personal data obtained through a closed-circuit camera system in accordance with the Law No. 6698 on the Protection of Personal Data ("PDPL" or "Law") due to your visit, as well as the transfer of your personal data and your legal rights regarding your personal data.

1. PROCESSED PERSONAL DATA AND PURPOSES OF PROCESSING

The processed personal data consists solely of video recordings from security cameras that do not capture audio recordings of you.

Mode Medikal processes your personal data in accordance with the law and in a manner that does not harm your fundamental rights and freedoms; specifically, your personal data subject to this clarification text is processed for the purposes of ensuring information security processes and physical space security in compliance with regulations.

The visible security cameras within the workplace begin recording your images from the moment you enter the premises, and these recordings are stored for security purposes. Areas that could infringe on privacy are not subject to monitoring beyond security purposes. The number of cameras in the workplace is limited to what is necessary to ensure data security.

2. METHODS OF COLLECTING PERSONAL DATA AND LEGAL REASONS

Your personal data is collected by Mode Medikal through monitoring activities carried out by security cameras, in accordance with the fundamental principles set forth by the PDPL, under the processing condition specified in Article 5, paragraph (f) of the Law, which states that "processing is necessary for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the relevant person."

3. TRANSFER OF PERSONAL DATA, PURPOSES OF TRANSFER, AND STORAGE PERIODS

Your personal data processed within the scope of this clarification text may be shared with public institutions and organizations, law firms, or judicial authorities for the purpose of ensuring physical security, protecting legitimate interests, and fulfilling obligations arising from regulations. Personal data recorded through closed-circuit camera systems is stored for a period of one (1) month.

4. RIGHTS AND OBLIGATIONS OF THE PERSONAL DATA OWNER

You can submit your requests under Article 11 of the Law, which regulates the rights of the relevant person, to the Company according to the "Communiqué on the Procedures and Principles for Application to the Data Controller" using the contact information provided below.
