

COOKIE DISCLOSURE TEXT

This Disclosure Text has been prepared by Mode Medikal Sanayi ve Ticaret Limited Şirketi (“Mode Medikal” or “Company”) in its capacity as the data controller, in accordance with Article 10 of the Law No. 6698 on the Protection of Personal Data (the “Law”) and the Communiqué on Procedures and Principles to be Complied with in the Fulfillment of the Obligation of Disclosure. The purpose of this Cookie Disclosure Text is to inform you about the types of cookies we use, the purposes for which we use them, the legal basis for their use, and your rights regarding the processing of personal data obtained automatically through the placement of cookies on your device. **On our website, only first-party session and persistent cookies that are strictly necessary for providing the service are used.**

1. TYPES OF COOKIES

Types of cookies based on their duration of use:

Session cookies are used to maintain the continuity of the session and are deleted when the user closes the browser. Persistent cookies, on the other hand, are not deleted when the internet browser is closed and are automatically deleted at a specific date or after a certain period. In this context, our website uses session and persistent cookies according to their durations.

First-party and third-party cookies:

First-party cookies are placed directly by the website that the user is visiting, which is the address shown in the browser's address bar. Third-party cookies are placed by a different domain outside of the address visited by the user. In this context, only first-party cookies are used on our website.

Types of cookies based on their purposes:

Cookies can be used for strictly necessary purposes, functional purposes, or for advertising/marketing purposes. In this context, strictly necessary cookies are used on our website to provide the information society services you have explicitly requested. In this scope:

A. A first-party persistent cookie named **cookiesession1** is used on the website to understand whether the subsequent requests to the page are trustworthy (it is stored for one year).

B. A first-party session cookie named **ASP.NET_SessionId** is used to determine the language in which visitors view the webpage.

C. A first-party persistent cookie named **cookiepolicy_status** is used to confirm that the cookie disclosure text has been read (it is stored for one year).

Your personal data is processed by associating it with your IP information. The personal data mentioned in this Disclosure Text is not transferred to any other place.

The processing of personal data through these cookies is based on the condition specified in the second paragraph (f) of Article 5 of the Law No. 6698 on the Protection of Personal Data, which states that “Processing data is necessary for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the related person.”
